The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is NADAL VENDING SERVICES INC.

## ARTICLE II - PURPOSE

This corporationis organized for the purpose of transacting any and all lawfull business permitted under the laws of Florida.

## ARTICLE III - CAPITAL STOCK


