* ARTICLES OF INCORPORATION * for

* A&M AUTOMOTIVE SERVICE, INC. *

In compliance with the requirements of F.S. Chapter 607, the undersigned, LAURA WISEMAN, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is A&M AUTOMOTIVE SERVICE, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III

The street address of the initial principal office of the corporation is located at 800 South Highway 17-92 DeBary FL 32713. The initial mailing address of the Corporation is also 800 South Highway 17-92 DeBary FL 32713.

ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is 1,000 shares of voting common stock having no par value.
