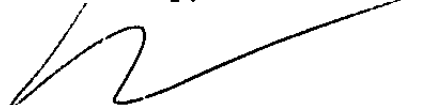

ARTICLE I - CORPORATE NAME

The name of this corporation is C & S LAWN MAINTENANCE, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this  
corporation is to engage in any and all business permitted under
