

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation shall be: B & L KAT, INC.

ARTICLE TWO
INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS
