BE IT KNOWN:

I, the undersigned Incorporator, being licensed to practice law in the State of Florida, do hereby form a professional corporation under the laws of the State of Florida and adopt the following articles of incorporation for the corporation:

ARTICLE I

The name of this Corporation is: WILLIAM SCHWEIKHARDT, P.A.

ARTICLE II

This corporation is organized for the following purposes:

a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation.

b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.

ARTICLE III

The maximum number of shares of stock which this Corporation is authorized issue shall be 50 shares with a par value of \$10.00.

ARTICLE IV

The principal office of this Corporation shall be located at Suite 203, 900 Sixth Avenue, So. Naples, FL. 33940.

ARTICLE V
