In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE ONE

NAME: The name of this corporation shall be "Edwards' Taekwondo Plus, Inc."  
2401-B Langley Avenue  
Pensacola, Florida 32504

ARTICLE TWO

DURATION: The duration of this corporation is perpetual.

ARTICLE THREE

PURPOSES: The general purposes for which this corporation is organized are:

1. To engage in the business of operating a Taekwondo center.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

STOCK: The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and

shall have a par value of One Dollar (\$1.00) per share.

#### ARTICLE FIVE

INITIAL REGISTERED OFFICE AND REGISTERED AGENT: The initial registered office of this corporation shall be located in Pensacola, Escambia County, Florida, and the address of such initial registered office shall be 2401-B Langley Avenue, Pensacola, Florida, 32504, but this corporation may change the location and address of such initial registered office from time to time by action of its Board of Directors without amendment to these Articles of Incorporation, and may have such other offices within the State of Florida as may be necessary or convenient. #### ARTICLE SIX

BOARD OF DIRECTORS: The number of directors constituting the initial board of directors of this corporation is two (2). The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one (1). 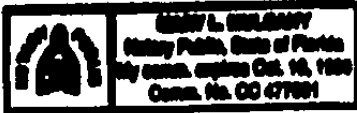
