ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS WILMA'S A.C.L.F., INC.

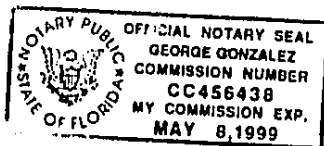

