ARTICLES OF INCORPORATION OF CHAN'S MOTT STREET RESTAURANT, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

Article L. Name. The name of the Corporation shall be CHAN'S MOTT STREET RESTAURANT, INC.

Article 2. Principal Officer. The principal place of business and the mailing address of this Corporation shall be 1295 East Hallandale Beach Blvd., Hallandale, FL 33009.

Article 3. Shares. The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$.10 per share.
