We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities and liabilities of Incorporation for profit.

ARTICLE I

The name of the corporation should be:

The corporation will engage in any activity or business permitted under the laws of the State of Florida and the United States of America.

The amount of capital with which its corporation may begin doing business shall be not less than five hundred dollars (\$500.00).
