ARTICLES OF INCORPORATION

The undersigned incorporator delivers these Articles of Incorporation in order to form a professional service corporation under the Florida Professional Service Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Guy Yves Pelchat, D.C., P.A

ARTICLE II

Principal Office

The principal office and mailing address of the Corporation is located at 6300 North Wickham Road, Suite 113, Melbourne, Florida 32940.

ARTICLE III

Corporate Purposes

The sole purpose of the Corporation is to engage in the practice of chiropractic and such business activities, including the ownership of real and personal property, as are necessary and incidental to the rendering of such professional services. The Corporation may invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment.

ARTICLE IV

<u>Duration of the Corporation</u>

The existence of the Corporation shall commence on the date these Articles of Incorporation are filed with the Department of State and all fees are paid and the Corporation shall exist perpetually unless dissolved according to law.

Shareholder Limitations

Section 9.1. Issuance of Stock. Section 9.3. Prohibition Against Shareholder Voting Agreements. No shareholder of the Corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of their stock.

Section 9.4. Disqualification of Shareholder. If any director, officer, shareholder, agent, or employee who has been rendering professional service to the public becomes legally disqualified to render chiropractic services within the State of Florida or accepts employment that, pursuant to law, places restrictions or limitations upon that persons' continued rendering of chiropractic services, such person shall sever all employment with, and financial interests in, this Corporation.
