**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following articles of incorporation:

**ARTICLE I NAME**

The name of the corporation is **INTERNET FOOD TRADE CORP.**

**ARTICLE II DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE IV PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal place of business of the corporation is at 13657 S.W. 117th Lane, Miami, Florida 33186. The mailing address of the corporation is the same.

**ARTICLE V AUTHORIZED SHARES**

The aggregate number of shares that the corporation has authority to issue is

five thousand shares, all of which shall be common shares with par value of \$1.00 per share.
