

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

The undersigned, as the president and secretary of CDK DRILL SHAFTS CORP., a corporation organized and existing under the laws of the State of Florida, do hereby certify that:

1. Name of Corporation: CDK DRILL SHAFTS CORP.
2. Amendment. ARTICLE III of the Articles of Incorporation is hereby amended to read as follows:

"ARTICLE III  
Capital Stock

The Corporation is authorized to issue 100,000 shares of common stock having a par value of One Dollar (\$1.00) per share. Of the shares of common stock, 50,000 shall be designated as voting common stock and 50,000 shares shall be designated as non-voting common stock. Each of the said shares of voting common stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. 3. Stockholder Approval. All of the stockholders entitled to vote on this Amendment approved such Amendment on January 8, 1997.
