ARTICLE V - NAME OF REGISTERED AGENT AND ADDRESS

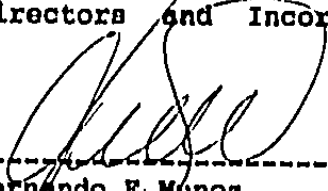
