We, the undersigned, horeby associate ourselves together for the no purpose of becoming a corporation under the laws of the State of Man Plorida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter with the powers, rights, privileges and immunities hereinafter mentioned, and we hereby make, submorths and acknow ladge and file with the Secretary of State of Plorida this Certificate of Incorporation, and to that ond we do, by this Certifica te, sat forth:

ARTICLE I

The name of this corporation (which is horeinafter called the "Corporation") is: RICOS QUALITY SEAFOOD, INC

ARTICLE II
