**ARTICLES OF INCORPORATION  
OF  
SHENANDOAH CONSTRUCTION, INC.**

The undersigned, for the purpose of establishing a corporation under Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is SHENANDOAH CONSTRUCTION, INC.

**ARTICLE II  
DURATION**

The corporation shall commence on filing and it shall have perpetual existence.

**ARTICLE III  
PURPOSE**

The purpose for which the corporation is organized is to operate a licensed building construction company; however, this corporation shall also have the power to do all things which now are, or may hereafter be, authorized for corporations under the laws of the State of Florida.

**ARTICLE IV  
PRINCIPAL OFFICE**

**ARTICLE V  
CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is 100, all of which shall be common stock with a par value of \$1.00 per share.
