Please be advised that this office has been retained by Ruby, Inc., a Florida corporation. Recently, you were contacted by Mr. James Layson, President of Ruby, Inc., regarding Ruby, Inc.'s inactive status. It is my understanding that Ruby, Inc. has been administratively dissolved for not filing its corporate annual report. However, Mr. Layson advised you that filing the corporate annual report was near impossible because control and operations of Ruby, Inc. had been criminally taken over by unrelated third parties. As a result, you advised Mr. Layson to document same and the Department would consider Ruby, Inc.'s request for a late filing without penalty. This correspondence shall constitute same.
