ARTICLE

NAME

The name of the Corporation is REACH & TEACH ENTERPRISES, INC. The address of the Corporation is 23242 St. Croix Place, Land O' Lakes, Florida 34639.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

PURPOSE
