I am writing you concerning "Heimann's of Pinellas, Inc.", a Florida corporation recently dissolved for failure to pay its annual registration fee and failure to submit its annual report.

This corporation was formed by myself and my wife for the purpose of operating a European-style restaurant in St. Petersburg. My wife and I were from Germany where I am an accredited master chef. We operated the restaurant together, when my wife died of cancer on April 17<sup>th</sup>, 2000. Since her death I have had a very hard time trying to operate the restaurant alone and without her help. During the period in which our corporation's annual corporate renewal came due, I was overcome with the great burden of trying to operate our restaurant alone - and also with the great burden of her loss.
