The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

Article 1

The name of the corporation is: **Dental Specialist Network, Inc.**

Article 2

The general nature of the business to be transacted by this corporation is:
a dental referral service

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Article 3

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 200 shares of common stock, having no par value.

Article 4

The amount of capital with which this corporation will begin business is not less than Five Hundred (\$500) Dollars.

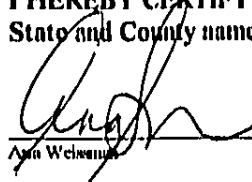
