ARTICLE I. CORPORATE NAME

The name of this corporation is Dryclean To Go, Inc.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

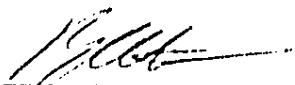
This corporation shall indemnify any officer or director and any former officer or director, to the full extent permitted by law.

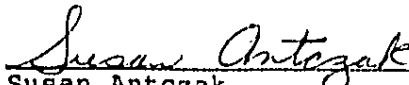

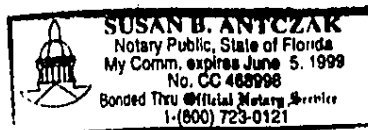

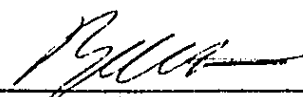
