The undersigned does hereby execute, acknowledge and file the following Articles (1.0) [DA of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### **ARTICLE 1**

The name of the corporation shall be:

The corporation shall commence its perpetual existence on April 29, 1996.

The general purpose for which this corporation is organized is to transact any and all lawful business permitted under the laws of the State of Florida.
