ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida Business corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is EXCELLENCE IN REALTY, INC.
- 2. PRINCIPAL OFFICE/ MAILING ADDRESS: The street address of the initial principal office and mailing address is 3401 49th Street North, St. Petersburg, Florida, 33710.
- 3. SHARES: The corporataion is authorized to issue one thousand (1,000) shares of One Dollar par value common stock. The shares shall be of a single class.
- 4.
