#### ARTICLES OF INCORPORATION

#### ConfiData, Incorporated

The undersigned, being a natural person, does hereby act as incorporator in adopting the following articles of incorporation for the purpose of organizing a stock corporation pursuant to the provisions of the Florida Business Corp. Act, Chapter 89-607:

FIRST: The name of the corporation (hereinafter called the corporation is ConfiData, Inc. SECOND: The duration of the corporation shall be perpetual.

THIRD: The purpose for which the corporation is organized, which shall include the transaction of any or all lawful business for which corporations may be incorporated under provisions of the Florida Business Corp. Act, Chapter 89-607, are as follows:

To provide small- to medium-sized businesses with the service of backing up their computer data over phone lines, at the same time performing hardware and software diagnostics on the customer's disk drive. Disk repair and upgrade services will also be offered.

To have, in furtherance of the corporate purposes, all of the powers conferred upon business corporations organized under the Florida Business Corp. Act, Chapter 89-607.

FOURTH: The total number of shares of capital stock which the corporation has authority to issue is 1000 shares of common stock with a par value of \$0.00.

FIFTH: No holder of any of the shares of any class of the corporation shall be entitled as of right to subscribe for, purchase, or otherwise acquire any shares of any class of the corporation which the corporation proposes to issue or any rights or options which the corporation proposes to grant for the purchase of shares of any class of the corporation or for the purchase of any shares, bonds, securities, or obligations of the corporation which are convertible into or exchangeable for, or which carry any rights, to subscribe for, purchase, or otherwise acquire shares of any class of the corporation; and any and all such shares, bonds, securities, or obligations of the corporation, whether now or hereafter authorized or created, may be issued, or may be reissued, or transferred if the same have been reacquired and have treasury status, and any and all of such rights and options may be granted by the Board of Directors to such persons, firms, corporations, and associations, and for such lawful consideration, and on such terms, as the Board of Directors in its discretion may determine, without first offering the same, or any thereof, to any said holder.

SIXTH: 1. The corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corp. Act, Chapter 89-607, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under are Bylaw, vote of stock holders, or disinterested directors, or otherwise, both as to action in his or her official capacity and as to action while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and dministrators of such a person.

The stated capital of the corporation may be reduced by the Board of Directors, without the assent of the stockholders.
