ARTICLES OF INCORPORATION

OF

AARD WOLF, INC.

The undersigned incorporator to these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida .

ARTICLE I

NAME

The name of the corporation is AARD WOLF, INC.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The initial address of the corporation's principal office and mailing address is 2213 Clarcona Road, Apopka, Florida 32703-7907.

ARTICLE III

DURATION AND COMMENCEMENT OF CORPORATION EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

ARTICLE IV

NATURE OF BUSINESS

The corporation is organized for the purpose of transacting any and all lawful business.

### CAPITAL STOCK
