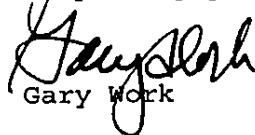

ARTICLES OF INCORPORATION
OF
THOMPSON'S APPLIANCE REPAIR, INC.

ARTICLE I

The name of this corporation is **Thompson's Appliance Repair, Inc.** The principal office of the corporation shall be located at 917 North 58th Avenue, Pensacola, Florida 32501, but meetings of members and directors may be held at such place within the State of Florida, County of Escambia, as may be designated by the Board of Directors.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The general purposes for which the corporation is organized are to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE V

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.

ARTICLE VI

The street address of the initial registered office of this corporation is 1940 St. Mary Avenue, Pensacola, Florida 32501,

and the name of the initial registered agent of this corporation at that address is Gary Work.

ARTICLE VII

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one (1). Members of the Board of Directors of this corporation need not be residents of the State of Florida or shareholders of the corporation. ARTICLE VIII

ARTICLE IX

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation. The proposed amendment shall be adopted upon receiving the affirmative vote of the holders of a majority of the shares entitled to vote thereon.

ARTICLE X

The effective date of the corporation shall be as of the filing with the Secretary of State and the acceptance by the Secretary.
