ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MCCURLEY AND SAYRE RESIDENTIAL, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, the Articles of Incorporation do the above named corporation having document # P96000038765, and originally filed on May 6, 1996, are amended as follows:

FIRST:

Article IV - Capital Stock is amended to read as follows:
