ARTICLES OF INCORPORATION
OF

19 MIO, CORP.

ARTICLE I

The name of this corporation is 19 MIO, CORP.

ARTICLE II

The term for which this corporation shall exist shall be perpetual.

ARTICLE III

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To provide financing to individuals and entities.

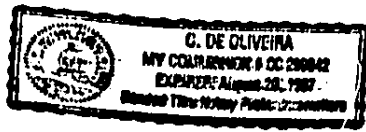
