ARTICLE I
NAME

The name of the Corporation is: SPECIAL TOUCH WEDDINGS & CRAFTS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 2107 E. College Ave., Unit 4, Box 11, Ruskin, FL 33570.

ARTICLE III
PURPOSE

The general purposes for which the Corporation is organized are:
