ARTICLE I. CORPORATE NAME

The name of this corporation is: **TEMPLE TERRACE LEARNING CENTER, INC.**, where the principal office is: 5604 E. 122nd Avenue, E., 122nd Avenue, Tampa, FL 33613.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The aggregate number of shares which this corporation shall have authority to issue is 1,500 shares of common stock having a NON Par value per share.

ARTICLE IV. TERM OF EXISTENCE.
