ARTICLE I

Name

The name of the corporation is LAPLUME, Inc. (hereinafter called the "Corporation").

ARTICLE II

Principal Office

ARTICLE III

Common Stock

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

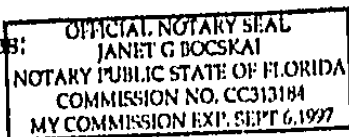
