**ARTICLE I - NAME**

The name of the corporation shall be: **TODAY'S TALENT, INC.**

**ARTICLE II - PRINCIPAL PLACE OF BUSINESS**

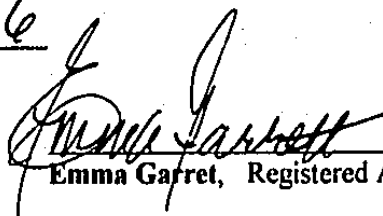
