ARTICLES OF INCORPORATION  
OF  
ONOV, INC.

ARTICLE I. NAME. The name of the corporation is ONOV, Inc.

ARTICLE II. PRINCIPAL OFFICE, REGISTERED OFFICE AND REGISTERED AGENT. The initial registered office of the corporation, which is also the principal office and mailing address of the corporation, is 2431 Aloma Avenue, Winter Park, FL 32792. The registered agent at this address is Dale D. Helling.
