

## ARTICLES OF INCORPORATION OF MED-VAX TECHNOLOGIES ACQUISITION, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### Corporate Name and Principal Office
