ARTICLES OF INCORPORATION OF INTERNATIONAL JET TRAINING, INC.

ARTICLE 1 - NAME

The name of this corporation is International get Training, Inc. and is located at 1371 General Aviation Drive, Melbourne, Florida 32935.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.
