#### ARTICLES OF INCORPORATION

#### ARTICLE 1 - NAME

The name of the corporation is Jayne's Fine Ferniture. Inc.. 580 Drexel Avenue NE. Palm Dav. Florida 32907. (Principal Office and Registered Agent).

# ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

## ARTICLE III - PURPOSE

This corporation is organized for the purpose of transaction any of all lawful business.

# ARTICLE IV - CAPITAL STOCK
