The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLET

NAME

The name of this corporation shall be VIRTUAL ACCESS, INC.

ARTICLE II

PURPOSE

The general nature of the corporation shall be to engage in any business and/or enterprise which is legal under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock, which shall be designated as "Common Shares." All of said Common Shares shall be payable in cash, property or labor/services in lieu thereof at a just valuation to be fixed by the Board of Directors.
