ARTICLE OF INCORPORATION

ARTICLE I

The name of the corporation is TradePlace Enterprises, Inc.

ARTICLE II

EFFECTIVE DATE  
4-30-96

This corporation shall have perpetual existence, and shall commence upon signing and acknowledging these Articles.

ARTICLE III

This corporation is organized for the purposes of transacting any and all lawful business.

ARTICLE IV

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V

Except as other wise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holder of the outstanding common shares.

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VIII

This corporation shall have ONE director initially. The number of directors may increase or decrease from time to time by the By-Laws, but shall never be less than one (1).

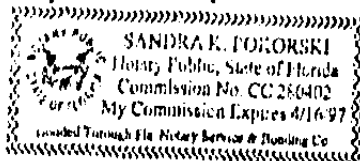
