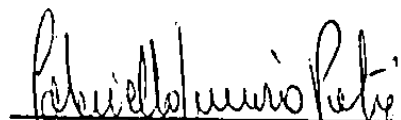

ARTICLES OF INCORPORATION  
OF

CYBETREKS, INC.

ARTICLE I. NAME

The name of the corporation shall be:

CYBETREKS, INC.

ARTICLE II.

This Corporation shall exist in perpetuity, commencing on the date upon filing with the Secretary of State of these Articles of Incorporation.

ARTICLE III. NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock, having \$1.00 (One Dollar) par value per share.

ARTICLE V.

SECTION I.

In the event of any voluntary or involuntary liquidation, dissolution, or winding up of this Corporation, the assets of the Corporation shall be payable to and distributed ratably among the holders of record of the Common Shares.

SECTION II.

Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series that which he thereof holds (as nearly as may be done without issuance of fractional shares) may purchase said stock at the price at which it is offered to others.
