To purchase, take, receivo, lease, or otherwise acquire, own, hold, improvo, use, and otherwise deal in and with roal or personal property or any interest thorain, wherever situated;

To soll, convey, mortgage, pledge, create a security interest in, lesse, exchange, transfer, and otherwise dispose of all or any part of its property and assots;

To lend money to, and use its crudit to assist, its officers and employees in accordance with Florida Statuto S607.141;
