SECRETACY OF STATE TALLAHASSEE, FLORIDA

#### **ARTICLE 1**

The name of the corporation is FLORIDA SMOKED FISH COMPANY (hereinafter called the "Corporation").

#### <u>ARTICLE II</u>

The address of the principal office and the mailing address of the Corporation is: 1111 N.W. 159th Drive, Miami, Florida 33169.

#### **ARTICLE IV**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

#### **ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

#### **ARTICLE V**

#### ARTICLE VI

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.
