ARTICLE VI

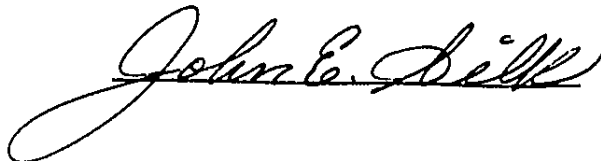

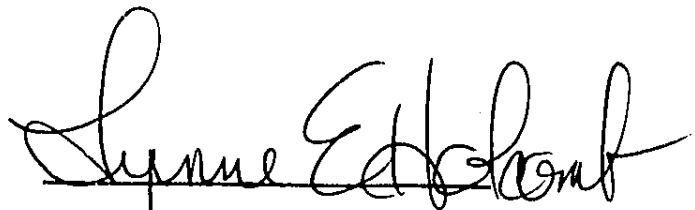
