ARTICLE I - NAME

EFFECTIVE DATE

The name of this corporation is CERTIFIED CONSTRUCTION ESTIMATES, INC.

ARTICLE II - CORPORATE EXISTENCE

The existence of this corporation shall commence on the 1st day of May, 1996; provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law for the commencement of corporate existence. The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

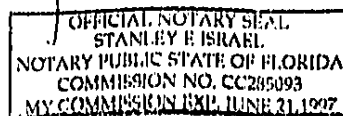
