Pursuant to the provisions of Section 607.1008, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE ONE

The name of the corporation is Aerostaff Services of America Inc. (the "Corporation"). The document number of the Corporation is P96000039795.

ARTICLE TWO

The following amendment to the Articles of Incorporation, as amended, was adopted on June 20, 2008, by written consent actions of the Corporation's directors and sole shareholder.

Effective June 20, 2008, Article One and Four of the Corporation's Articles of Incorporation, as amended, are hereby deleted in their entirety and the following inserted in their place:

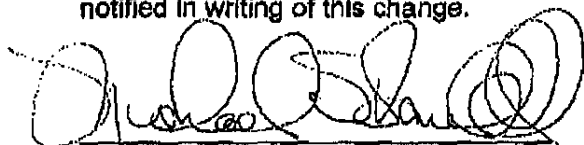
