ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is MULTI-PRO, INC. and 13876 S.W. 56th Street, Miami, FL 33175, respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK
