We, the undersigned subscribers, are organizing a corporation for profit pursuant to the Statutes of the State providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be RIVER CROSSING OFFICES, INC., and the principal place of business of said corporation shall be at 6709 Ridge Road, Suite 200, Port Richey, Florida 34668.

ARTICLE II

The registered office of said corporation shall be in Pasco County, Florida, which address shall be 6709 Ridge Road, Suite 200, Port Richey, Florida 34668 and JOHN E. HUDSON is hereby designated as the Registered Agent for service of process for said corporation at said address.

ARTICLE III

The purpose of the corporation is to engage in any activities or business permitted under the laws of the State of Florida or the United States.

ARTICLE IV

This corporation shall be authorized to issue Five Thousand and no/100 Dollars (\$5,000) in stock as follows:

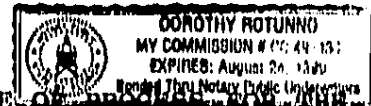
