ARTICLE I. NAME

The name of this corporation is SILICON DESIGN RESOURCES, INC.

ARTICLE II. PURPOSE

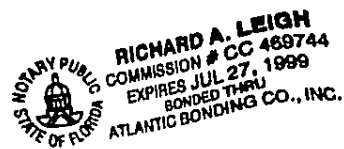
