Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation hereby files these Articles of Amendment:

ARTICLE ONE

The name of the corporation is SILICON DESIGN RESOURCES, INC.

ARTICLE TWO

The following amendment (the "Amendment") to the Articles of Incorporation was unanimously adopted by the directors and the shareholders of the Corporation effective August 18, 1998.

The Amendment alters Article I of the articles of incorporation filed May 6, 1996, and the full text of the provision as amended is as follows:

ARTICLE I

The name of the corporation is SRDR Associates, Inc.

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.

ARTICLE FOUR

The number of shares voted for such amendment was 1,000; and the number of shares voted against such amendment was 0. This vote was sufficient for approval of this amendment.


