DURATION

POWER TO FORM PARTNERSHIP**

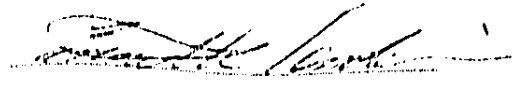

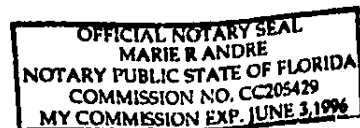

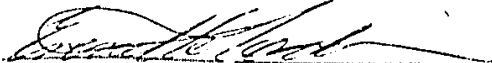
