The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, does hereby adopt the following Articles of Incorporation:

### ARTICLE I

The name of this corporation shall be COMPRESSION ON CALL, INC.

### ARTICLE II

The corporation shall have perpetual existence, unless sooner dissolved according to law.

# ARTICLE III

The general nature of the business or businesses to be transacted by this corporation shall be: to buy, sell, trade, and otherwise deal in any and all manner of durable medical equipment and supplies;


