

**ARTICLES OF INCORPORATION
OF
INTEGRATED STRATEGIES GROUP, INC.**

Pursuant to the Florida Business Corporation Act, these Articles of Incorporation provide that:

I. NAME

The name of this corporation shall be:

INTEGRATED STRATEGIES GROUP, INC.

II. COMMENCEMENT OF EXISTENCE

Corporate existence shall commence as of May 1, 1996.

III. TERM OF EXISTENCE

EFFECTIVE DATE

5-1-96

This corporation is to exist perpetually.

IV. NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

V. CAPITAL STOCK

The aggregate number of shares of stock which this corporation is authorized to issue is 100 shares of common stock. The par value of the shares is \$0.01.

VI. REGISTERED AGENT AND OFFICE

VIII. INCORPORATOR




